

## **Data Protection**

### **Pursuant to and in accordance with Article 13 of D.LGS 196/2003**

With regard to the current legislation concerning protection of personal data we inform you that our company will collect or may already hold your personal information including sensitive or judicial data, in order to supply the services (1) requested by you.

The information supplied by you or others (2) is only that which is strictly necessary and it will be recorded on paper, digitally and via IT provision or by a combination of two or more of these methods. The processing is done in such a way to guarantee the safety and privacy of the information, pursuant to and in accordance with article 11 of the D.lgs 196/03 and will include all the transactions foreseen by art. 4, comma 1, letter a) as necessary, in order to supply the services requested by you including the insertion of that information on a database directly managed by Thank You Italia S.r.l. and the sharing of the same information with third parties with whom we collaborate either temporarily or permanently, in Italy or abroad; for this however we will use persons whom we trust and who carry out technical, organizational and operative (3) duties on our behalf, in Italy or abroad.

Your personal data may be supplied to our specifically authorised colleagues acting as managers or representatives and who will use the data in order to fulfil the above indicated aims. Your data will not be circulated. Without your data – some of which you will need to give us or be supplied by third parties by law (4) – we cannot supply part of our services or any of our services.

You have the right to know which of your personal data we hold at any time, together their origin and how they will be used; you may change, update, supplement or cancel data as well as block or oppose its use. (5)

The controller is Thank You Italia S.r.l. And the designated person, should you exercise the right as per art. 7 D.Lgs 196/03, is Mr Flavio Toracca.

Any information regarding your personal data or third parties it may be passed on to as mentioned above can be supplied by the designated person (Mr Flavio Toracca)

Based on the above, by indicating in the appropriate space, you can agree to the handling of your personal data by the Company– including any sensitive information – and its communication to third parties as mentioned

The right to oppose can be used with regard to publicity material or direct sale or market research or commercial communication. In other cases opposition suggests a legitimate reason.
